

General Remarks and Stipulations

Location

The land is situated on the eastern side of Moorends Road on the northern fringe of Moorends. The town of Thorne lies approximately two miles to the south and the town of Goole lies approximately ten miles to the north east. Please refer to the Site Plan on the front page of these particulars.

Description

The land comprises a single grass field which is of a reasonably regular shape and is suitable for mowing or grazing of stock.

The land is classified as being Grade 2 on Sheet 103 of the Provisional Agricultural Land Classification Maps as historically published by the Ministry of Agriculture Fisheries and Food.

The soils are identified by the Soil Survey of England and Wales as being from the "Blacktoft" association with the characteristics described as "deep stoneless permeable calcareous fine and coarse silty soils" and as suitable for "sugar beet, potatoes and cereals".

Basic Payment Scheme

It is not known whether the land is registered on the Rural Land Register. However, if it is not, it can be registered and then used to activate entitlements under the Basic Payment Scheme. There are no entitlements available from the Landlord.

Network Space Land Limited.

Terms of the Tenancy

- 1. The Land is to be let on a two year fixed term Farm Business Tenancy, with effect from 15 September 2021. The rent shall be payable six monthly in advance on 15 September and 15 March each year. A copy of the proposed Farm Business Tenancy agreement is available for inspection at the Letting Agent's office, by prior appointment, or can be emailed on request.
- 2. The Tenant shall be responsible for all outgoings.
- 3. The Tenant shall keep and leave in repair all fences, gates, ditches, drains etc.
- 4. The Tenant shall be responsible for all maintenance of hedges, (as applicable).
- 5. The Tenant may not assign or sub-let the tenancy.
- 6. The Tenant will use the land for agricultural/grazing purposes only.
- 7. The Landlord will not allow any land to be used for outdoor pig production.
- 8. The Landlord will not allow any genetically modified crops to be grown on the Holding.
- 9. The Landlord will not allow any sewage sludge to be used on the Holding.
- 10. The Tenant(s) must not spray within 1 metre of any field boundary.
- 11. There will be no tenantright payable, likewise there will be no consideration or allowance made whatsoever for any dilapidations or any other deductions.

Outoings

Drainage rates are payable to the Black Drain Drainage Board.

Viewing

The land may be viewed at any reasonable time during daylight hours in possession of a set of these sale particulars.


