General Remarks and Stipulations

Location

The land is situated to the south of Willow Bridge Lane to the west of Braithwaite, within the Parish of Moss. The City of Doncaster lies approximately eight miles to the south west.

Description

The land comprises a useful grassfield used for both making hay and for grazing.

The land is classified as being Grade 4 on Sheet 103 of the Provisional Agricultural Land Classification Maps as historically published by the Ministry of Agriculture Fisheries and Food.

The soils are identified by the Soil Survey of England and Wales as being from the "Foggathorpe 2" Association with their characteristics described as "stoneless clayey and fine loamy over clayey soils" and as suitable for "cereals and grassland with stock rearing."

Basic Payment Scheme

The land has not been registered by the Vendor on the Rural Payments Agency Rural Land register.

Tenure and Possession

The land is owned freehold and it is being sold with the benefit of vacant possession upon completion.

Outgoings

Annual drainage rates are payable to Danvm Drainage Commissioners.


