General Remarks

Location

The land is located off Swinefleet Road A161 when travelling from Goole towards Swinefleet and is located to the south east of The Barracks and accessed via a farm track. The land is edged red on the attached plan and the access being marked green

Description

The land extends in all to 3.34 acres (1.39 hectares) or thereabouts being part of field No. SE 7521 8617 and has been in arable cultivation and is left in stubble.

The land is accessed via a track from Swinefleet Road A161 which is shown green on the attached reference plan.

Drainage Rights

The land is sold subject to a drainage rights in the favour of the owner of the adjoining property to the north - "Wentworth" for a water discharge pipe from a drainage treatment plant in the grounds of Wentworth which discharges into the drain to the south of the land being sold the approximate position of which is shown by a blue line on the attached plan.

Tenure and Possession

The land is sold Freehold with the benefit of vacant possession on completion.

Viewing


The land may be viewed during the day light hours without the need for a specific appointment upon receipt of these sales particulars
